Commonly asked *questions* about *hail damage*

How do I know if I have hail damage to my roof?

A qualified professional must make a close, on-site inspection of the roof. In most cases, damage cannot be observed from the ground.

What does hail do to a roof?

Hail will drastically shorten the life of your roof. Hail causes bruising, which causes hairline cracks and tears the felt underlayment under the shingle, which in turn allows slow water penetration. Simply put, uncontrolled water penetration and your house don't mix.

Should I replace the roof right away?

Many insurance companies have a "statute of limitations" dictating how long a hail claim is valid for. It is imperative that you file a claim immediately in order to determine any damage. If your insurance company finds enough damage to warrant the replacement of your roof, do not hesitate to have it replaced.

What about my siding?

Check your exterior walls very closely for dents and holes. During morning or evening hours will make it easier to see the denting. Old aluminum siding will show damage more than wood or vinyl, unless the vinyl actually has holes in it.
